Appendix

- **a:** "Full-time, degree-seeking students" are defined as those students who are either currently studying full-time on Carleton's campus, participating in remote learning, or participating in college-approved off-campus studies programs.
- **b:** The count of "first-year" students includes all students in the first three terms of their academic progression at Carleton. This number is not equal to the fall 2020 count of first-time, first-year students, which was **453**.
- **c:** "Legal sex" refers to a student's sex as reported to the US federal government.
- **d:** The "four groups" ethnic categories are used internally at Carleton. For the purposes of this field, "students of color" are defined as domestic students who identify, even in part, with a non-white racial/ethnic identity.
- **e:** The "US Geographic Origin" categories include only those students who are US citizens residing either in one of the 50 states, on a US military base, or in a US territory or possession.
- **f:** Students with "Waiver of senior residency" status are neither enrolled nor in residence on campus. They may be participating in a 3-2 program, may have completed all degree requirements, or may be completing final requirements, such as comps.
- **g:** For the purposes of this report, "remote learning" students are defined as those students who are enrolled full-time at the college, but are not living in a college-owned residence, on Northfield option, or participating in college-approved off-campus studies programs. These students opted not to return to Northfield and are completing their coursework remotely.
