Appendix

- a:** Students pursuing an undergraduate degree who are either currently studying full-time on Carleton's campus or participating in college-approved off-campus studies programs (OCP).
- b:** The count of "first-year" students includes all students in the first three terms of their academic progression at Carleton, "sophomore" the second three terms, "junior" the third three terms, and "senior" the remaining terms.
- c:** Refers to a student's sex as reported to the federal government. Colleague does not store gender identity.
- d:** Includes only those students who are U.S. citizens residing in one of the 50 states, on a U.S. military base, or in U.S. territory or possession. The remaining students are counted as N/A.
- e:** The "four groups" ethnic categories is an internal-to-Carleton designation.
- f:** Domestic students who identify, even in part, with a non-white racial/ethnic identity.
- g:** Students not enrolled and in residence on campus but may be participating in a 3-2 program, may have completed all degree requirements, or may be completing final requirements, such as comps.
- h:** Students are not pursuing an undergraduate degree but are still reported for federal & state compliance.
- i:** Includes Language Associates.
- j:** Includes only non-Carleton students on one of Carleton's GEP programs. Carleton students on a GEP program are counted as full-time, degree-seeking students.
