

## **SUMMARY ANNUAL REPORT**

### **For Carleton College Health & Welfare Comprehensive Benefit Plan**

This is a summary of the annual report of the Carleton College Health & Welfare Comprehensive Benefit Plan, EIN 41-0694747, Plan No. 510, for period 01/01/2025 through 12/31/2025. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Carleton College has committed itself to pay certain self-insured Medical and Employee Assistance Program claims incurred under the terms of the plan.

### **Insurance Information**

The plan has contracts with Delta Dental of Minnesota, Vision Service Plan, and Unum Life Insurance Company of America to pay Dental, Vision, Life Insurance, Long-term Disability, and Accidental Death and Dismemberment claims incurred under the terms of the plan. The total premiums paid for the plan year ending 12/31/2025 were \$1,408,376.

The contracts with Delta Dental Of Minnesota are so called "experience-rated" contracts, the premium costs are affected by, among other things, the number and size of claims. Of the total insurance premiums paid for the plan year ending 12/31/2025, the premiums paid under such "experience-rated" contracts were \$623,882 and the total of all benefit claims paid under these contracts during the plan year was \$524,297.
